Patent translation – what you need to know

Translations for the patent sector need to be precise, accurate and exact with confidentiality at the heart of the process.

Patent Translation

Translation refers to the translation of the written word, and the scale, depth and range of documentation required is immense.

Not surprisingly, choosing a translator who has specific experience of your sector will not only ensure accuracy and precision but will also speed up the process. They will be familiar with legal terminology and styles of writing and will also have a wider knowledge of patent documentation and areas of expertise.

Requiring direct, clear and concise language, a patent translation needs to describe exactly what the original text states, without including cultural equivalents or approximations in the target language. Make sure you use a translator with an in-depth knowledge of the law, the patent requirements of each country, the home tongue of the application or disclosure and knowledge of specific terminology.

Timescales

Translators usually translate approximately 2000 words per working day. By giving your translation company enough time to handle your documentation, you can be assured of the absolute best quality work, using the right specialists for the job. For more urgent applications, documents can be split between multiple translators.

Sworn Translation or Affidavit

A sworn translation may be necessary for official documents, intended to be used abroad or required for use in a court of law. An affidavit is a sworn statement in which the translator testifies that the attached translation is a true and accurate translation of the original document.

Certification

It is possible that you may be asked for the translation to be certified, handled by a certified translator, sworn or even notarised. You should ensure the company you use for translation is an accredited one - City Legal, for example, is a full member of both the Association of Translation Companies and the Institute of Translation and Interpreting. These are both benchmarks of quality in the UK translation industry and recognised at government level.
